Connellsville City Council Minutes April 21, 2015 This regular meeting of the Connellsville City Council was held this evening at 6:00 PM at City Hall, Connellsville, PA. Attending this meeting was Mayor Lincoln, Council members Geyer, Zolbrod, Karpiak and Ritch. Also attending this meeting was Shelley Primus, Administrative Secretary and Solicitor Witt. PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Rev. Brian Higbee led invocation Reminder of the procedures for public participation during City Council meetings. Police Promotions: John James and Tom Patton REMARKS FROM VISITORS/PUBLIC COMMENTS: Bob Topper, New Haven Hose Co., Requested Council revamp the False Alarm Ordinance to include New Haven Hose and enforce that ordinance; ISO Report, New Haven Hose Co. received a 5; Explained what an ISO Report is; Fund Drive next week; May 9th is New Haven's Neon Nights at 8:30 PM Mia Christie, Adopt a Grandparent, Program through her school Melissa Tzan, Recreation Board update of events and Summer Camps; This Saturday is Cleanup Connellsville; Movie in the Park schedule; Mountz Creek pavilion is almost done; Deanna Richter is new member; Need volunteers; October 2nd is Tangled Up in Brew CITY TREASURER JAYNES REPORT: Councilman Karpiak questioned how we are doing this year with the tax increase as opposed to last year. The majority of the votes being affirmative, the resolution was adopted. KARPIAK: Public Works Report Councilman Karpiak announced there is compost available to the Street Department garage. Resolution No. 4-11-2015: "To hire the following individuals for summer employment: Michael Parlak, Wesley White, John Blocker and Ryan Huey; pay to be a rate of \$7.50 per hour for a maximum of 35 hours per week for a maximum of twelve weeks, such cost to be taken from line item 01430-145; pending completion of New Hire Paperwork." Company will be given a time line of 21 days to have this work completed. Money to be taken from Miscellaneous Contingencies 1480-546." The meeting with PA American Water Company concerning the Fire Hydrant Maintenance Cleanup Day this Saturday Resolution No. 4-14-2015: "To adopt Bill No. 3 of 2015: An ordinance of the City of Connellsville amending Ordinance No. 996, enacted February 27, 1967, amending Ordinance No. 1211, enacted April 13, 1981, and amending Ordinance No. 1507, enacted April 15, 2014; regulating the demolition and removal of certain buildings within the City of Connellsville; requiring permits; setting demolition and removal bond amounts; and prescribing penalties for violations therefor." A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmen Geyer, Zolbrod, Karpiak and Ritch and Mayor Lincoln. The majority

of the votes being affirmative, the resolution was adopted. Resolution No. 4-15-2015: "To direct the City Solicitor to record the following lien and further direct the Solicitor to execute the Sheriff Sale process: \$900 for the property known as 510 West Gibson Avenue (Parcel ID 05-06-0002). All cost associated with this process shall be added to the lien and sale value." Resolution No. 4-16-2015: "To approve and sanction the City-Wide Cleanup Event scheduled for April 25, 2015, to be organized by Aaron Zolbrod and other organizations and groups in the local area, at no cost to the City; and to approve the use of East Park, or other City parks, for purpose of organizing and holding said Event." A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmen Geyer, Zolbrod, Karpiak and Ritch and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted. Resolution No. 4-17-2015: "BE IS RESOLVED to transfer and assign title to the City's certain 2004 Spartan Fire Truck (VIN 4S7HT2D934C047685) to New Haven Hose Company to be used for firefighting, fire suppression, and fire protection purposes, such fire truck to become the responsibility of New Haven Hose Company; on the conditions that 1) any sale of the fire truck within ten (10) years of the date of transfer must be approved by City Council, and 2) fifty percent (50%) of the proceeds of such sale are returned to the City, unless otherwise waived by the City; and further authorizing and directing the Mayor and City Clerk to execute all documents and to perform all actions to effectuate such transfer and assignment." A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmen Geyer, Zolbrod, Karpiak and Ritch and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted. Resolution No. 4-18-2015: "That this meeting of City Council does hereby adjourn."
