Connellsville City Council MINUTES 5 PM – MARCH 19, 2024

This meeting of the Connellsville City Council was held this evening at 5:00 PM. Attending this meeting was Council members Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. Also attending was City Clerk Ohler and Solicitor Witt.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Led by Chuck Hubble

The meeting began with two Public Hearings.

PUBLIC HEARING #1: ARI HOLDINGS, LLC, TO VACATE A PORTION OF AN UNNAMED TWENTY-FOOT ALLEY EXTENDING BETWEEN NORTH THIRD STREET AND NORTH FOURTH STREET

Solicitor Witt stated there was a petition from ARI Holdings, the property owner on both sides of that alley. He noted there are no other affected property owners but the City is required to hold a public hearing. Solicitor Witt added it is a paper alley and is not opened. He reiterated that they must have this public hearing and hear any public comment, if there is any.

Councilman Keedy asked if anyone has a comment on vacating the alley. There was no comment. Councilman Keedy questioned if he could close the hearing.

Solicitor Witt stated they will note that there is no comment in respect to that, so they can close that hearing.

Councilman Keedy announced the second Public Hearing.

PUBLIC HEARING #2: TRAILSIDE LANDING RESTAURANT AND EVENT CENTER, LLC, TO TRANSFER RESTAURANT LIQUOR LICENSE R-14359 INTO THE CITY OF CONNELLSVILLE FOR USE IN OPERATION OF A RESTAURANT AND EVENT CENTER ON PREMISES LOCATED AT 235 NORTH FIRST STREET, CONNELLSVILLE, PA.

Councilman Keedy questioned if anyone has a comment on the transfer of the liquor license.

Solicitor Witt stated anytime there is a transfer of a liquor license from one municipality to another, it requires the approval of the governing body of which it is being transferred. He noted under the liquor code, the City is required to do this.

No one was present to speak at this meeting. Councilman Keedy stated they will note there was no public comment and close that hearing.

REMARKS FROM VISITORS/PUBLIC COMMENTS: No public comment

CITY TREASURER'S REPORT: Absent

Councilman Keedy noted the report is in everyone's packets and the Tax Office has been extremely busy and running extremely well.

CITY CONTROLLER'S REPORT: Given by Controller Korba

CORRESPONDENCE:

New Haven Hose, Neon Night 5K Run/Walk, Street closure request on May 4, 2024

Councilman Keedy questioned City Clerk Ohler what the time is for the race.

City Clerk Ohler answered we were not given a time or map.

Councilman Keedy questioned Solicitor Witt what council should do.

Solicitor Witt replied the options for council are to wait to approve it because the information is not available, or to approve it subsequent conditions of the times and approval of the mayor, Penn DOT, Police Chief and Fire Chief.

Resolution No. 3-1-2024: "To approve New Haven Hose's request for the annual Neon Nights 5K on May 4, 2024 subsequent of times and route; pending review and approval of the Mayor, PennDOT, Police Chief and Fire Chief of street closures and times."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

Solicitor Witt added council does not normally approve an event that way, but this is an event that is held annually with a successful track record.

LeAnne Triggs, Request for music, electric and stage at Yough Park on June 22, 2024

Resolution No. 3-2-2024: "To grant permission for LeAnne Triggs to use electricity at Yough Park and have musical performances on the stage at Yough Park on June 22, 2024 for a graduation party."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

Mr. McFadden, Connellsville Veterans Commission, Memorial Day Parade, May 27, 2024 at 10 AM

Resolution: "To grant permission to the Connellsville Veterans Commission to sponsor a Memorial Day Parade and service on May 27, 2024; lineup to begin at 9:30 AM at the corner of South 1st and 3rd Streets and parade to begin at 10 AM moving north on 3rd Street to Yough River Park for the service; further authorizing items listed on the Utilization Form be delivered by the Public Works employees to Yough Park for the Memorial Day Service; Pending review and approval of the Police Chief and Fire Chief."

Councilwoman Tiberio stated she feels it will be congested in that area.

Councilman Topper added there is not a lot of parking.

Councilman Keedy questioned if the construction will be going on there.

Councilman Topper answered they probably will not be working on Memorial Day, but the equipment will be there.

Councilwoman Tiberio added St. Rita's has a mass on Memorial Day. She suggested that maybe they could just convene somewhere.

Councilman Addis stated the service is at the Riverpark.

Councilman Topper questioned if they are reaching out to all of the fire departments and "is it going to be as big as it usually is"?

City Clerk Ohler answered that they did not get into specifics and he did tell them the City's concerns and they still want to have it.

Councilman Keedy asked where they are lining up at.

City Clerk Ohler answered First through Third Streets and up head up to Youghiogheny Glass, with traffic control. He added that it will be congested over there.

Councilman Addis stated no matter what event there is over there, it will all be congested.

City Clerk Ohler added there is no parking for anyone who wants to come and watch.

Councilman Addis noted he hopes they keep this in mind when they do the invites.

Councilwoman Tiberio requested they table it and get more information.

City Clerk Ohler answered they can table it.

Councilman Keedy asked Solicitor Witt if they can do that by email and ratify it at the next City Council Meeting.

Solicitor Witt replied it is not an expenditure of City Funds, so it can be done that way. He noted that is the other alternative if it had to be done by the next meeting.

City Clerk Ohler suggested tabling it and notify them of council's concerns. He added they may change their mind.

Councilwoman Tiberio suggested asking the Police Chief his thoughts on it.

Police Chief Hammerle stated his thoughts are they should limit their invitations to very few. He added they deserve to have it, but not with lots of trucks and only local departments.

Councilman Topper suggested only one truck.

City Clerk Ohler suggested "military only."

Councilwoman Tiberio suggested where the Honor Roll is.

City Clerk Ohler stated that cannot be done because of traffic.

Councilman Keedy stated he is making a motion to table it until they get more information. Councilman Topper seconded the motion. The resolution was tabled.

Connellsville Festival Association, Red, White and Boom Festival, July 6, 2024

Resolution No. 3-3-2024: "To permit the following road closures for the 2024 Red, White and Boom Festival from 9 AM to 11 PM on July 6, 2024, West Crawford Avenue from Pittsburgh Street to Arch Street, Water Street from Peach Street to Fairview Avenue and Apple Street from North Arch Street to Water Street; pending approval from the Police Chief and the Fire Chief; further approving items listed on the Utilization Form."

Councilman Keedy stated things will be done differently this year. He noted it is usually done at the fire station in front of City Hall, but due to the fire truck and ambulance in the station it will be held on Crawford Avenue. He added the main strip is basically shut down anyway. They will be in front of City Hall because people will be walking down here to see the firework, he added.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

REGULAR AGENDA:

Resolution No. 3-4-2024: "To accept the minutes from the February 20, 2024 City Council Meeting."

Resolution No. 3-5-2024: "To waive the Four-Day Resolution Rule to allow for items submitted after the Four-Day Rule to be read at the meeting tonight, such Resolutions will be marked with an asterisk."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

MAYOR LINCOLN: Absent

Mayor Lincoln was absent. His department was read by Councilman Keedy.

Police Department Report by Chief Hammerle

Councilman Addis questioned what is going on with the new car.

Chief Hammerle answered he called the outfitter and is waiting for an answer. He noted the last he spoke to them; the equipment is on back order.

Councilman Topper asked if the body cams are working out well.

Chief Hammerle answered the body cams are working out great and car cams are working fantastic. He added he hopes the next grant they apply for; they get so all the cars would be equipped and they will have new portable radios. He added that the new servers are taken care of.

Chief Hammerle discussed the traffic situation on North Pittsburgh Street at 119 and all the congestion. He stated the NO LEFT TURN signs have been installed and no one is listening to them. He added they would have a hard time enforcing that because he would have to send half of his department down there and pull cars over as they come through, which is often. Chief Hammerle stated they are trying to get flashing lights on those signs to make them more aware and people see them better. He added he would like to see Jersey barriers put up but he is not sure if Penn DOT would approve that.

CDBG and CV Programs Report

HWY. SUPPLY ROAD, DUNBAR, FAYETTE COUNTY TO TRAILSIDE LANDING RESTAURANT AND EVENT CENTER, LLC FOR USE AT 235 NORTH FIRST STREET, UNIT 1, CONNELLSVILLE, FAYETTE COUNTY, PENNSYLVANIA."

WHEREAS, the Liquor Code of Pennsylvania as amended by Act No. 141 of 2000 to provide, inter alia, that an inter-municipal transfer of a license must first be approved by the governing body of the receiving Municipality when the total number of existing restaurant liquor licenses, eating places and retail dispenser licenses exceed one license per 3,000 inhabitants; and,

WHEREAS, pursuant to 47 Pa. C.S.A. § 461 (b.3) of the Liquor Code of the Commonwealth of Pennsylvania, as amended, the City Council held a public hearing with respect to the proposed transfer of an existing liquor license held by Patricia Brown, which is presently in safekeeping with the Pennsylvania Liquor Control Board ("PLCB"), and was formerly operated at 180 Hwy. Supply Road, Dunbar, Fayette County, Pennsylvania, to Trailside Landing Restaurant and Event Center, LLC for use at a premises within the City of Connellsville with an address of 235 North First Street, Unit 1, Connellsville, Fayette County, Pennsylvania; and

NOW, THEREFORE, BE IT RESOLVED, and it is hereby resolved by the City Council of the City of Connellsville that the request to transfer an existing liquor license (PLCB Liquor License No. R-14359) held by Patricia Brown to Trailside Landing Restaurant and Event Center, LLC, to a premises within the City of Connellsville with an address of 235 North First Street, Unit 1, Connellsville, Fayette County, Pennsylvania, is hereby approved."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 3-7-2024: "To permit the City Clerk to apply for a Pennsylvania Department of Environmental Protection 902 grant on behalf of the City."

Councilman Keedy questioned what this grant will be used for.

City Clerk Ohler replied another dump truck for the public works and a composting area by the Public Works garage.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

Resolution No 3-8-2024: "To grant an easement to West Penn Power for access through the City parking area that borders North 3rd Street, North 2nd Street, and North First Street."

Councilman Keedy questioned what this is.

City Clerk Ohler responded this is needed for the event center to have electricity.

Councilman Addis questioned if the City could request it be underground to keep a pole out of the parking lot.

City Clerk Ohler stated he will make a phone call.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 3-9-2024: "To adopt an "Incident/Accident investigation Policy as recommended by the Safety Committee to be entered into the Employee Policy and Procedure Manual."

Councilman Keedy asked the City Clerk to explain this resolution.

City Clerk Ohler answered through the Safety Committee, we were told through Labor and Industry that we need this. He also noted it makes the City's insurance agent happy.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Addis, Keedy, Topper and Tiberio. Mayor Lincoln was absent. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 3-10-2024: "To permit the City Clerk to submit for the Congressionally Directed Spending Grant on behalf of the City."

Councilman Keedy questioned what the City is submitting for.

City Clerk Ohler answered the City is submitting for funding for the Pedestrian Bridge at Dutch Bottom and the Pedestrian Tunnell by Cash Saver.

Public Works Report

Resolution No. 3-28-2024: "To introduce Bill No. 1 of 2024: An ordinance of the City Council of the City of Connellsville, Pennsylvania, approving the vacation of a portion of an unnamed twenty-foot alley located in the City of Connellsville, County of Fayette.

WHEREAS, ARI Holdings, LLC, Kevin Leonard, Casey Leonard, and Barcine Graft have petitioned and requested that a portion of an unnamed twenty-foot alley abutting their properties identified as Tax Parcel Nos. 05-06-0524 an 05-06-0525;

WHEREAS, said portion of said unnamed alley is used as private yard areas and are not used by the public for purposes of public travel; and

WHEREAS, the City of Connellsville does not maintain said unnamed twenty-foot alley;

WHEREAS, the Third-Class City Code, 11 Pa.C.S.A. § 12919 requires any street or alley vacation ordinance to be advertised prior to consideration and final passage; and

WHEREAS, a public hearing was held before the City Council on the 16th day of April, 2024; and **WHEREAS**, the petitioners have agreed to meet certain conditions, including, without limitation and with respect to certain petitioners, the release, waiving, and indemnifying the City of any damages as an adjacent property owner.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CONNELLSVILLE, PENNSYLVANIA, DOES ORDAIN AS FOLLOWS:

SECTION 1: That the following described portion of an unnamed twenty-foot alley is hereby vacated, except as may be expressly provided in this Ordinance:

Approximately one hundred sixty-five (165) feet of said unnamed twenty-foot alley, being that existing, unopened, and unvacated portion of an unnamed alley extending westwardly from the western right of way line of North Third Street for approximately one hundred sixty-five (165) feet, with a width of twenty (20) feet, to the eastern right of way line of North Fourth Street as shown on Exhibit A attached hereto.

SECTION 2: Reservation of Easement. An easement is hereby reserved and retained, as a condition of approval of the petition, for all of that portion of the above vacated property as a perpetual easement or

rights-of way for any existing pipes, pipelines, or other infrastructure, for the construction, maintenance, repair, relocation, and operation of existing pipes, pipelines, or other infrastructure, without any liability for damages on the part of the City, and no permanent buildings or structures shall be located within or upon said easement without the prior written consent of the City. Petitioner shall execute all necessary documents identifying and conveying such easement to the City.

SECTION 3: Conditions of Vacation. The vacation is contingent on the Petitioner providing any releases, easement reservation instruments, or any other confirmatory documents requested by the City. The petitioner, and its successors and assigns, has agreed and acknowledged that no proceedings for the award of damages may be had and no damages as a result of the vacation of the aforementioned road within the City of Connellsville shall under any conditions be awarded to it.

SECTION 4: Constitutionality or Invalidity. If any section, subsection, clause, phrase, or sentence, of this Ordinance, is for any reason held to be invalid or unconstitutional, such invalidity or unconstitutionality of the remaining portions of this ordinance, as it is being hereby expressly declared that this ordinance and each section, subsections, clause, phrase, or sentence, hereof would have been prepared, proposed, adopted, and approved and ratified irrespective of the fact that any one or more section, subsection, clause, phase, or sentence, be declared invalid or unconstitutional.

SECTION 5: Effective Date. This Ordinance shall be in full force and effect thirty (30) days from and after passage, and publication as provided by law, and upon full completion of the conditions provided herein. **SECTION 6:** Recordation. The Petitioner is directed to file this ordinance with the Clerk of Courts, Fayette

County, Pennsylvania, and record this ordinance with the office of the Recorder of Deeds, Fayette County, Pennsylvania.

SECTION 7: Implementation. The Mayor and City Clerk are hereby authorized to implement such administrative procedures as may be necessary to carry out the directives of this Ordinance."

All bids must be submitted by April 16, 2024 at 4:00 PM to Widmer Engineering and will be open on April 16, 2024 at 5 PM at Connellsville City Hall, 110 North Arch Street, Connellsville, PA 15425."
