# Connellsville City Council MINUTES 5 PM – MARCH 18, 2025

This meeting of the Connellsville City Council was held this evening at 5:00 PM. Attending this meeting was Council members Addis, Keedy, Topper and Tiberio and Mayor Lincoln. Also attending was City Clerk Rita Smith and Solicitor Witt.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Led by Pastor John W. Friend

#### **PUBLIC COMMENT:**

Mayor Lincoln stated the timer will be set to three minutes and Solicitor Witt will let us know when the three minutes is up.

Nina Pleva, Discussed backyard chickens

Thank you for letting me speak today. My name is Nina Pleva, I live in the city of Connellsville, I am coming to you to propose the idea of urban homesteading in Connellsville.

Homesteading with backyard chickens is rapidly increasing in popularity. There was a 50% increase in backyard chicken ownership from 2018 to 2020 according to The American Pet Products Association. This is a good selling point for people looking to move to Connellsville as well as a retaining point for people already established. One family we spoke with while preparing for today told us they moved out of Connellsville due to not being able to keep chickens. That is just one family that we know of, imagine how many have moved over the years or who would not consider moving to Connellsville for this reason.

As long as we are responsible and respectful chicken owners there are many benefits to having backyard chickens.

Chickens eat rodents, ticks, and other bugs, keeping pests down. Many people incorrectly think chickens attract rodents, but instead that can be from open food containers. I would propose keeping chicken food contained and using a no waste chicken feeder. Chickens also greatly reduce food waste by eating kitchen scraps.

We can control what is going into our foods by controlling what we feed our chickens. Holistic minded people can choose not to feed their chickens soy because of it being a known hormone disruptor. RFK is making more people aware of harmful chemicals going into our foods. Store-bought eggs are washed in chemicals such as QAC-quaternary ammonium compounds, sodium hypochlorite, or bleach, sodium carbonate, propylene glycol and surfactants. Due to the porous nature of an egg, these chemicals can be introduced into the egg and thus into our food product. Many people have been told they have an allergy to eggs, but are in fact reacting to the chemicals used to process eggs for the supermarket. They discover this when they are able to eat farm fresh eggs with no issue. Also, the average egg from the grocer is 45-60 days old, losing nutrient density as time passes.

Farm fresh eggs have a protective coating on them that is called a bloom. When we have our own chickens we can leave this antimicrobial protective coating intact. It protects the egg from bacteria and germs, including Salmonella. Salmonella can come from eating undercooked foods that are contaminated, and from lettuce and other produce found in grocery stores. Backyard chicken owners can decrease the risk of bacteria and germs by cleanliness and handwashing. Backyard chickens have been found to have a lower rate of salmonella than commercial farms according to a study done by North Carolina State University. Joel Salatin cited a study done in the UK where feeding chickens 2 blades of grass a day ensures they do not get avian influenza. Commercially raised chickens live their lives without seeing any grass or eating the good foods that produce more nutrient dense eggs, increasing their risk of diseases compared to backyard chickens.

Dogs are notably noisier than chickens. Dogs bark at around 90 decibels, where a hen will cluck at around 53 decibels. Also, when dogs go on walks they deposit their liquid waste all over the neighborhood, whereas backyard chickens will keep their waste contained in the owner's yard. The chicken waste can then be composted for nutrient rich garden food.

Many people consider chickens as pets, and chickens respond to their names. Some people have chickens as emotional support animals, allowing us the pursuit of happiness as promised us in the Declaration of Independence.

Our founding fathers wrote the constitution to protect the people from the overreach of the government, not the other way around. It is a basic human right to grow and raise our own food. This is important for our freedom as well as our health. Our forefathers strongly believed in living off of the land and responsibly caring for the land and our families. I am trying to be respectful and responsible by requesting a chicken ordinance for the city of Connellsville. My friend and I combed through the ordinances of Connellsville and could not find one on keeping chickens, but we did find pigs and hogs mentioned. The only ordinance we found mentioning chickens was in dealing with cruelty to animals.

There are many large cities across America allowing backyard chickens, such as Los Angeles, Detroit, Seattle, and our very own Pittsburgh. In fact, in the city of Pittsburgh, on my lot of just under 5000 square feet, I would be allowed to keep 8 chickens or ducks, bees, and/or 2 miniature goats. Most of our surrounding towns allow chickens as well, such as Uniontown, Everson, Scottdale, Mt. Pleasant, East Huntingdon, Latrobe, and South Connellsville, which is two blocks away from my residence. Their ordinances all state that chickens cannot be at large, no roosters, and specify numbers of chickens allowed.

South Connellsville, which allows ten chickens per lot less than 5 acres, no roosters, and requires a roofed coop, has recently been in the news for people who are not adhering to the ordinance. I do not agree with that behavior and would like to make that clear. According to the article that I read in our local paper, the people are free ranging a larger number of chickens and roosters and they are bothering the neighborhood. I feel that these people should be cited as appropriate, and this behavior not tolerated. I do not think we should punish everyone for a few people not following the law. As an example, we should not all have our drivers licenses revoked due to some people driving under the influence.

Connellsville would benefit from an ordinance on backyard chickens. I would propose 5 hens per household, perhaps more for larger acreage, to be kept in a coop and run with a roof, not to be free ranged, and no roosters. We should also not be selling eggs to the public, thus not increasing traffic to the residential areas.

I have attached the ordinances from South Connellsville and Pittsburgh for your reference.

Thank you so much for your time on this matter.

Solicitor Witt notified everyone the three minutes is up and asked Ms. Pleva to summarize the topic. He added Council does have her statement in writing.

Mayor Lincoln added he is reading along and likes it.

Nina Pleva continued to discuss the backyard chickens.

Mayor Lincoln questioned Solicitor Witt on how South Connellsville is doing with their Chickens in the Borough.

Solicitor Witt replied they have complaints on non-compliance issues. He added some people who have chickens are not taking responsibility for the chickens by allowing them to run wherever and they cannot be identified as to who they belong to. He noted that unlike the city, South Connellsville does not do their own zoning and the County zoning applies to them which does not allow chickens in certain zones. He continues that if it is within a permitted zone, they still have to follow that ordinance of the County. Solicitor Witt added it is positive in some respects to certain people; however, they have received complaints as well.

Mayor Lincoln questioned if the city adopted an ordinance, could they limit it to owner occupied homes only or do they have to include all homes.

Solicitor Witt replied he does not know the answer but will look into it. He continued his initial thought is that they may not be able to limit it exclusively to owner occupied because it could raise constitutional issues of treating certain classes of people differently.

Mayor Lincoln stated the Code Officer is not for having urban chickens within the city limits. He requested Tom Currey, Code Officer, to give his input on this subject.

Tom Currey, Code Officer, stated if this is done correctly, the chickens could work. He noted he is concerned that it will not be done correctly. He added he is concerned that it will be the same people that he deals with on a regular basis and they cannot take care of their dogs and cats. Currey stated that you are allowed chickens in the City of Connellsville under a "Use by Special Exemption" in the Zoning Ordinance out on the highway which is C2 District and the Industrial District. He continued that you have to apply for it and get the city zoning and get the special exemption and go to the Zoning Hearing Board and fill out any use by reasonable restrictions on that. Currey informed council that a change to the Zoning Ordinance would require a mailing to every resident affected and that cost needs to be kept in mind. He continued that they do attract a lot of animals and pests and if they do not have a roof on a pen,

run or down on the ground, there is going to be rats, mice, fox and coyotes, skunks and more. He added if it is being done for financial reasons, it is cheaper to buy eggs at the store. Currey pulled an article from the internet which states it costs about \$68 a month for five chickens. He clarified that is to five years old to lay eggs and then you get rid of the chickens; and they live five years after that. Currey concluded it does not include that expense or the expense of vet bills if a cat would come in and tear at the chicken and it needs to go to the vet. He stated the eggs would be healthier for you to eat if done correctly. He noted the store bought are older and decline in nutrition as they get older. Currey reiterated that it is the execution he is worried about in the city.

Mayor Lincoln questioned if he understands correctly that it is allowed in Industrial and C2 Districts.

Tom Currey answered yes.

Mayor Lincoln questioned if there is something in the language that states how they are allowed to raise the chickens in that area.

Tom Currey answered no.

Mayor Lincoln questioned if they can just go get chickens and be free ranging?

Tom Currey stated "They need to apply with the City and it is called a Use by Special Exemption through the Zoning Hearing Board. They go to the Zoning Hearing Board and present how they are going to raise the chickens. The Zoning Hearing Board gets to put any reasonable restrictions on to that." He stated the board could state they have to put a fence up between the property and the neighbors and you have to have this many feet in the coop for this many chickens. He continued that what is reasonable and unreasonable are between the two parties, the board and applicant or the court system if they decide to go that route.

Councilman Addis stated he feels that they need an ordinance no matter what.

Mayor Lincoln stated if they are already permitted in those two areas why would not, we want to have some kind of verbiage that states what you can and cannot have.

Solicitor Witt stated right now, the city indirectly has it but it is at the discretion of the Zoning Hearing Board. He explained if Council wants to have a more specific parameters of what the

responsibilities are for chicken raising in those areas, then you would want to have a more specific ordinance.

Mayor Lincoln questioned right now they can go to the Zoning Hearing Board, and if they are not happy, they then go to Court of Common Pleas, correct?

Solicitor Witt answered, yes.

Mayor Lincoln then stated if the city has their own, then it would eliminate them going to a higher court, correct?

Solicitor Witt answered yes and no. He explained yes, if the city had clearly articulated criteria in an ordinance, then everyone is subject to these criteria. He continued that is could be challenged that it is unreasonable criteria and you would have to open it up to more than a special exemption use. Witt reiterated that someone could still argue that it is unreasonable restrictions.

Mayor Lincoln questioned if the city could put a permit fee for someone applying for chickens and use that money for this?

Tom Currey stated it is \$325.00.

Mayor Lincoln stated that is zoning. He clarified that if council decided to have an ordinance of their own and added a fee on this, then we would use that money for this. He questioned if the county has any say on this.

Solicitor Witt answered the county does not have a say on the ordinance.

Councilman Keedy stated it would be expensive to redo the Zoning Ordinance.

Solicitor Witt answered there is considerable cost involved in it; the work involved and the notices the code officer pointed out and the hearings that you have to go through to do this.

Councilman Keedy questioned if the chickens would then be considered pets?

Solicitor Witt answered no.

Councilman Keedy gave a scenario of him being a landlord and has a trouble tenant and that tenant is not leaving. He continued that this falls back on who is going to do this the right way. He questioned if the chickens are running around and neighbors are complaining, how long until the chickens are not allowed in that nuisance area? He asked if they can be stopped.

Solicitor Witt answered you have to go through the process.

Councilman Keedy questioned if it is a lengthy process.

Solicitor Witt explained this is what South Connellsville is going through right now by receiving multiple complaints over a stretch of weeks as a result of chickens running loose. They are trying to deal with how do they deal with this issue.

Councilman Keedy stated there is only so much council can do.

Mayor Lincoln questioned if the city can limit how many permits are given.

Solicitor Witt answered there is a procedure where you can limit the total number of permits issued.

Councilman Addis stated that someone having multiple tenants and there is not enough yard for tenants to have chickens, should not that be up to the landlord to decide if they want to allow their tenants to have chickens. He noted it is just like a dog and cat. He continued it would take the landlord out of it.

Solicitor Witt answered it should. He noted he would advise the landlord to have it in the lease.

Councilman Addis stated he would personally consider the chickens like cats in the city and we have a problem with those.

Councilman Topper questioned who does the code enforcement in South Connellsville.

Solicitor Witt answered they hire a third-party code officer.

Councilman Topper stated then it would be a code officer dealing with neighbors' complaints and chickens getting out.

Solicitor Witt stated the code officer in South Connellsville had to stake out to identify how many chickens there are.

Mayor Lincoln stated he thought South Connellsville's ordinance stated the chickens had to be enclosed and not running around.

Solicitor Witt answered he is unsure.

Councilman Addis questioned if the city could make the owners band or tag the chickens around the leg.

Solicitor Witt answered that could be done as a requirement.

Councilman Addis stated farmers do it and that takes the issue of finding out who they belong to out of the equation.

Solicitor Witt stated this comes back to the people who do not follow the rules.

Councilman Addis questioned that if they do not follow the rules, why can't the chickens be taken out?

Solicitor Witt replied then who is responsible for that, which is the issue they have in South Connellsville.

Councilman Topper stated he is sure there are people who would do it responsibly and could absolutely benefit from it and it be a very nice thing. He continued, unfortunately, there are people who would not be responsible. He added what worries him is do they confiscate someone's chickens and what do we do with them; do we sell them to someone else who wants chickens? He stated when he moved back to Connellsville Twelve Years ago, his neighbor had chickens and a rooster. He added the neighbors stated they did not know it was a rooster and it was loud day and night for months until someone turned them in. He questioned now do they take a rooster away from someone who did not know it was a rooster? He noted she was not happy to give her rooster up. He clarified that he worries about what are they going to do when they run into an issue.

Tom Currey stated that you cannot identify sexes of the young chickens.

Councilwoman Tiberio questioned what if neighbors decide to take matters into their own hands.

Councilman Topper stated they is what they are worried about.

Councilman Addis stated the neighbors are doing that with the cats and they are not doing anything.

Councilman Keedy stated it could be an issue that when you go to the magistrate to try and rectify the issue, it continues in the court system and takes time and the problem is still happening.

Councilman Topper agreed that it will just drag out for months.

Councilman Keedy stated you have to worry about those that do not do the right thing.

Mayor Lincoln stated they deal with code enforcement every day.

Councilman Addis stated yes, every day.

Name unknown in the audience questioned that there is no ordinance in the city, so how can you enforce something that is not in writing? She continued that Tom keeps bringing up the industrial and highway and she does not live in the industrial or highway so that does not affect her or anyone else that we are fighting for this for. She questioned again; how do you enforce something that is not actually an ordinance and keep going back to this special exemption which is not fair. She continued that there are drunk drivers on the road every day, we are not taking cars off of people every day and there are people who are irresponsible in every area of their life and people who overdose on opioids and we are still giving them out in hospitals. She added you cannot say that some people are irresponsible so nobody gets to benefit from this. She stated she lived on a farm and now lives in a rural area and stated chickens do not attract all the pests, they eat the rodents, people have misconceptions about chickens. She again stated one bad egg can ruin it for everyone. She again stated that when there is no clear ordinance, it is not fair to try and enforce something that is not even in writing legally, and keep going back to the special exemption that does not apply to her and everyone she is fighting for. She went on with cats are more dangerous than chickens and chickens are not dangerous or carry diseases where a cat can send you to the hospital. She explained a cat bit and what it could do to a human. She asked council to consider all of this and not punish the responsible people because of the unresponsible people.

Solicitor Witt stated his understanding is that it is covered under the Zoning Ordinance. He suggested deferring this to the Zoning Officer.

Name unknown in the audience stated there is not one word in the ordinance that states chickens.

Tom Currey, Code Officer, stated she is exactly right. Councilman Keedy stated that it is not allowed because it does not say it is allowed, correct?

Tom Currey answered that is exactly right, it is a use that is not listed. He explained there is a table with specific uses in all the specific zones and all uses could not possibly be listed. He continued that there is a section that states that if a use is not listed, which is use by special exemption in the industrial zone and the C2 highway zone district.

Mayor Lincoln questioned that if it does not say you are allowed to have chickens in our zoning ordinance, that means that you are not allowed to have chickens.

Tom Currey answered correct but there is "other uses not listed" special exemption under industrial zone and C2 highway zone areas only.

Mayor Lincoln questioned why is it those areas only.

Tom Currey answered the city has to provide for every single use thing. He continued the City has impound lots which are not listed in the zoning ordinance and that is use by special exemption in a proper zone. He clarified that every single use not listed falls into that category.

Mayor Lincoln questioned in order for the chickens to be allowed anywhere in the city, they would have to create a new ordinance.

Solicitor Witt answered amend the zoning ordinance.

Tom Currey answered yes, a new use of the zoning ordinance and everyone affected would have to go through the whole process of changing the zoning.

Councilman Keedy questioned if you put the restrictions in the ownership to raising and what all would go into raising them in the zoning ordinance or a separate chicken ordinance?

Solicitor Witt answered it would probably be easier to have the more specific rules in a separate ordinance, but you would have to change the zoning ordinance to permit it as a general rule with the caveat with the condition it would adhere to any other ordinance that the city might pass with the raising of the chickens.

Tom Currey stated they apply for a special exemption for the Highway Zone right next to Rowan's, "you can have chickens right there or cows, you have to apply for the special exemption and we would take the Chicken Ordinance and say this is what we recommend doing and the guidelines that you should follow to come through and apply to the Zoning Hearing Board. The Zoning Hearing Board would say ok, you match these and what other stipulations apply."

Name unknown questioned what if someone does not live in that area is what you are not addressing.

Tom Currey answered that it is addressed in the Zoning Ordinance.

Name unknown stated if you do not live in the Industrial area, if you do not live in that area and cannot have the exemption.

Tom Currey questioned where she was when they passed the Zoning Ordinance. He apologized and stated that is the law.

Mayor Lincoln stated council would have to change that.

Name unknown stated other towns have the ordinance and it is not really being addressed.

Councilman Keedy asked Currey to let him know if he is wrong in stating goats is not listed in the Zoning Ordinance.

Tom Currey answered correct.

Councilman Keedy questioned if he is allowed to have goats in the C2 and Industrial Zones.

Tom Currey answered correct.

Councilman Keedy questioned, anything not listed in the ordinance falls under C2 and Industrial Zone?

Tom Currey answered correct.

Councilman Keedy then stated to get the chickens anywhere else in the city, we have to amend the Zoning Ordinance since it is not specified throughout?

Councilman Topper stated in order to allow the chickens in any other area in the city, they would have to go through the process of changing the zoning in every area that we want to allow it. He noted that takes times and can not be done with the stroke of a pen. Solicitor Witt stated it would take several months.

Councilman Topper stated that would be step one before they do anything else. He continued, then they would have to enact an ordinance for where it is allowed to have all the guidelines and everything that would set. He stated council will do their homework and look into it but it will not be something that will be on next month's agenda and just say yes to unfortunately.

Name unknown stated she appreciates council's time and looking into it.

Mayor Lincoln stated he is and Councilman Addis both get code enforcement complaints everyday and its all through the City and dealing with rental properties. He noted there are a lot of slumlords in the city and that is his fear of it all, adding more to that.

Name unknown questioned residential homes and eliminating apartments.

Mayor Lincoln stated he wants that and would love to do owner occupied, but know Solicitor Witt would tell him that would be discriminating against rental properties. He stated they could do restrictions to cut it down and add something like if there was multiple code violations or abuser or does not pay their taxes on their property. He continues there are things they can add for levels to protect council so they can do it correctly.

Name unknown stated as the pastor prayed earlier, if this is really the pursuit of happiness, the government is really infringing on our rights to be able to have freedom to raise our own food for our families. She continued, she has four children and six people in her house and I have five people in my house and I cannot eat store bought eggs. She noted she gets violently sick if she eats a store-bought egg. She added they should be able to have the freedom in the United States, free country and this really is our constitutional rights to be able to feed our families.

Mayor Lincoln stated they want to do it correctly; it will take time since council must amend the zoning and have public meetings and a very lengthy process to do.

Councilman Keedy noted certain people will not do this the right way and they have to figure out what to do to minimize that. He then questioned Currey when someone is going through the Zoning Hearing Board for an exemption, are the neighbors notified of this?

Tom Currey answered yes.

Councilman Keedy questioned if a person is applying for a chicken permit, would the neighbors be notified to weigh in on that?

Solicitor Witt answered if it is a special exception.

Councilman Keedy stated if council were to do an ordinance on that.

Solicitor Witt answered no.

There was a gentleman in the audience, from Connellsville Township, who stated he was there to hear what was going on because there was a woman in the township gathering signatures to allow chickens in the township. He noted zoning in the township is with the county. He noted he has had more complaints about chickens the past seven years than anything else.

Solicitor Witt stated the county amended their ordinance three or four years ago to not permit chickens because of the complaints that the county had gotten. He continued that prior to that it was permitted.

Shane Bunting, Senior at Connellsville Area School District and President of the Bible Club.

Mr. Bunting stated his club is hoping with the Easter season coming up, he is hoping they can host an Easter Service for the Community. He added they are willing to work with the Connellsville Ministerial Association if need be since they do not want to step on any toes. He continued it would be on Thursday, April 17<sup>th</sup> with an arrival time of 5 PM with games and a worship band with service at 5:30 PM from Pennsville. He continued there would be prayers from various students, three speakers and close with a communion service. Bunting stated there are girls who would like to head up a youth ministry during the service. He added there would be no admission fee and open to the community. His request is to have this service at Yough River Park.

Mayor Lincoln stated he feels this is a great thing and he is happy the Bible Club has grown and getting other students involved. He noted he knows at one point the club's room was full of

students and he commended Bunting and his club for their work. He added he is praying for good weather for the service. He stated the solicitor will write up a resolution.

Councilman Addis thanked Bunting for keeping the club going and being a good leader.

He explained if someone rents a pavilion that they will need to know it may be a shared splash pad.

Mayor Lincoln stated Public Works dug the trench out for the power to the polls for the cameras and they will have a light up like Washington Park. He stated four cameras are working and the other four should be hooked up this week and the whole park will be under surveillance.

Councilman Topper asked the public to watch their language and if anyone sees anything, let the police know. He noted they want the parks to be fun and safe and are investing a lot of money into them. He added they want everyone to go there and have fun with no issues.
